STORAGE AND DISPOSAL

GENERAL INFORMATION

Do not mix Valcheck Foam Marker with any other foam marker concentrate. Valcheck Foam Marker is a carefully tested blend of foam additives and stabilizers that may not be compatible with other products. A mixture will likely result in poor quality foam.

Valcheck Foam Marker is a synthetic non-protein foam concentrate designed to be used with conventional agricultural foam generators. Valcheck Foam Marker produces a dense highly visible foam of sufficient longevity under normal weather conditions which helps eliminate costly gaps or overlaps which can occur during the application of fertilizers and pesticides.

DIRECTIONS FOR USE

To ensure a good quality foam, be certain to flush and clean the foam generating equipment before use. Add 1 gallon of Valcheck Foam Marker for every 80 gallons of water (1 quart per 20 gals). To ensure proper mixing, either premix concentrate with water or fill the foam tank with half the desired amount of water, add the proper amount of Valcheck Foam Marker and add the remaining water.

The addition of water conditioners is generally not recommended as they have been built into the product. Where water contains high concentrations of minerals salts, it may be necessary to increase the Valcheck Foam Marker concentration to 1 gallon per 60 gallons of water.

Since foam stability is not predictable under all conditions of wind, humidity, temperature and exposure to sunlight, the user should make his own test to determine the optimum use rate of Valcheck Foam Marker for the particular situation.
