GENERAL INFORMATION

VECTOR may be used with registered pesticides in the following applications: Agricultural, Forestry, Horticultural, Industrial, Non-Cropland, Ornamental, Right-Of-Way, and Turf.

VECTOR is labeled for aerial and ground applications.

VECTOR is a highly concentrated, easy-to-use formulation of ammonium salts and specially designed polymers which acts as a deposition agent, foliar retention agent and canopy penetrating agent.

VECTOR is also a water conditioning agent that improves pesticide performance by reducing hard water antagonism in the spray tank.

VECTOR may be used with herbicides, insecticides and fungicides, unless specifically prohibited by the pesticide label.

DIRECTIONS FOR USE

Before mixing **VECTOR**, a compatibility test is recommended. See the pesticide label for detailed instructions on compatibility testing. If all components of the solution are compatible, add the contents of the compatibility test to the spray tank and begin the mixing process.

Users may add AMS, 28% UAN or other adjuvants as needed to meet the requirements of the specific pesticide label.

USE RATES

Aerial and Ground Application:

2 pounds of **VECTOR** per 100 gallons of spray solution.
(One – 6 pound bag treats 300 gallons of spray water.)

MIXING INSTRUCTIONS

IMPORTANT - Add **VECTOR** to the spray tank first before adding any other tank mix product, unless the tank mix pesticide(s) or additives direct otherwise.

Mixing Order

1. Fill tank 1/2 full of water and begin agitation.
2. Slowly add the required amount of **VECTOR** and allow the product to completely dissolve.
3. Continue filling spray tank with water and add the tank mix components as directed on the pesticide label(s).

STORAGE & DISPOSAL
