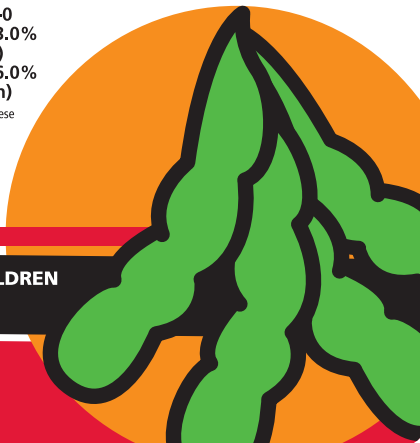

GENERAL INFORMATION

VERSA EDTA Mn 6% provides the micronutrient – manganese (Mn). Manganese is essential in plant growth – affecting carbohydrate and nitrogen assimilation, chlorophyll production and crop maturity.

VERSA EDTA Mn 6% is designed for soil and foliar applications in agronomic crops. **VERSA EDTA Mn 6%** is compatible with most fertilizers – including ORTHO based phosphate fertilizers.

VERSA EDTA Mn 6% is formulated to be compatible with glyphosate + AMS and other tank mixed foliar-applied pesticides.

APPLICATION RECOMMENDATIONS

Use in accordance with an approved nutrient management program. **VERSA EDTA Mn 6%** is intended to be used as a supplement to a standard fertility program.

Soil Applied Broadcast:

Apply 1 to 2 quarts/acre of **VERSA EDTA Mn 6%** for manganese maintenance.

Apply 2 to 3 quarts/acre of **VERSA EDTA Mn 6%** for moderate manganese deficiencies.

Apply up to 4 quarts/acre of **VERSA EDTA Mn 6%** for severe manganese deficiencies.

Row Starter Fertilizer Applications:

Apply 0.5 to 2 quarts/acre of **VERSA EDTA Mn 6%** with row starter fertilizers, in band at planting or side-dress applications.

TANK MIXING WITH FERTILIZERS

*Always perform compatibility or jar test with all the tank mix components, before mixing large quantities.

1. Fill tank at least ½ full of liquid fertilizer.
2. Pour in desired rate of **VERSA EDTA Mn 6%** while agitating.
3. Finish filling tank with liquid fertilizer with agitation running.
4. If needed, add other chemicals after the **VERSA EDTA Mn 6%** + fertilizer mix has been prepared.
5. Maintain consistent tank agitation, until tanks are empty.

Broadcast Foliar Applications:

Apply 1 to 2 quarts/acre of **VERSA EDTA Mn 6%** alone or with post-emerge pesticide applications. Total carrier volume should be at least 10 GPA.

FOLIAR TANK MIXING WITH PESTICIDES

*Always perform compatibility or jar test with all the tank mix components, before mixing large quantities.

1. Fill tank at least ½ full of water.
2. Add AMS based water conditioner adjuvants and other tank mix adjuvants (as needed), while agitating.
3. Pour in desired rate of **VERSA EDTA Mn 6%**, continue agitation.
4. Add pesticides per label, continue agitation.
5. Finish filling tank and continue agitation until tanks are empty.

NOTES

All micronutrient blends can potentially antagonize pesticides and tank mixes. Consult all tank mix product labels prior to adding **VERSA EDTA Mn 6%** to tank.

STORAGE & DISPOSAL

Store product in original container. Do not store near heat or open flame. Do not reuse container. Do not contaminate water, food or feed by storage or disposal. Keep packaging closed, securely fastened and upright. Product may suspend in layers if stored below 32°F.

Triple rinse (or equivalent) prior to disposal. Add rinsate to tank. Offer container for recycling or dispose of properly according to state and local authorities. If burned, stay out of smoke.
