GENERAL INFORMATION

VERSA MAX-Zn provides the micronutrient – zinc (Zn), to prevent or correct zinc deficiencies.

VERSA MAX-Zn is designed for soil applications – broadcast or row starter applications, in agronomic crops. **VERSA MAX-Zn** is not for foliar applications.

APPLICATION RECOMMENDATIONS

*Always perform compatibility or jar test with all the tank mix components, before mixing large quantities.

VERSA MAX-Zn is intended to be used as a supplement to a standard fertility program. Actual use rates should be based on soil tests, crop removal and yield goals.

Soil Applied Broadcast:

Apply 1 to 2 quarts/acre of **VERSA MAX-Zn** for zinc maintenance.

Apply 2 to 3 quarts/acre of **VERSA MAX-Zn** for moderate deficiencies.

Apply up to 4 quarts/acre of **VERSA MAX-Zn** for severe deficiencies.

Row Starter Applications:

Apply 1 quart/acre of **VERSA MAX-Zn** with row starter fertilizers. Do not use **VERSA MAX-Zn** with 100% orthophosphate-based fertilizers.

Weight Per Gallon: 10.1 pounds

STORAGE & DISPOSAL

Store product in original container. Do not store near heat or open flame. Do not reuse container. Do not contaminate water, food or feed by storage or disposal. Keep packaging closed, securely fastened and upright. Product may suspend in layers if stored below 32°F.

Triple rinse (or equivalent) prior to disposal. Add rinsate to tank. Offer container for recycling or dispose of properly according to state and local authorities. If burned, stay out of smoke.
