DIRECTIONS FOR USE

Foliar application:

- **Corn:** 4-16 fluid ounces per acre can be applied at key growth stages: V4 to V12 and/or V15 to R2.
- **Soybeans:** 4-16 fluid ounces per acre between R1 and R3.
- **Wheat:** 4-16 fluid ounces per acre at flag leaf.
- **Alfalfa:** 4-16 fluid ounces per acre after each cutting.
- **Cotton:** 4-16 fluid ounces per acre at early bloom.
- **Potatoes:** 8-16 fluid ounces per acre just prior to or at early tuber initiation. Option to apply 8-16 fluid ounces per acre again at early tuber bulking, and a third time of 8-16 fluid ounces per acre at mid tuber bulking. Total for the season up to 48 fluid ounces per acre, applied at 16 fluid ounces per acre three times.

Dosages are calculated for normal water distribution volumes.
