DIRECTIONS FOR USE

WECO-BOOST is recommended for blending with a complete fertilizer program and is not intended to be used alone.

Shake well before using.

Apply 8 fluid ounces of **WECO-BOOST** per acre, blended with liquid fertilizer or impregnated on dry fertilizer. For use on all crops.

COMPATIBILITY

WECO-BOOST is believed to be compatible with most agricultural water-soluble crop protection products. If physical compatibility with other products is unknown, use a jar test to test for compatibility.
