**WESN 14-0-0** is recommended for use on all indoor and outdoor agriculture and horticulture crops including, but not limited to, gardens, lawns, nurseries, and greenhouses.

This product can be applied as a foliar application by ground or air; or, through drench, drip or flood irrigation on soil. For drip irrigation, dilute with water 1:1500-2000. For foliar application, dilute with water 1:3000-4000.

When mixing with other products it is recommended that a physical compatibility test be conducted before use. A test using small quantities in proportion to field application rates is recommended. Apply as needed based on your nutrient management program determined from soil and plant tissue analysis for your specific crop.
