DIRECTIONS FOR USE

TURFGRASS: For maintenance of turfgrass, use 4.2 pounds of **WIL-GRO ALL AROUND** per 1,000 sq. ft. or 180 pounds per acre. For repair of damaged turf (such as divot repair, pet damage, traffic wear, insect or disease damage and/or drought stress) use 4.2 pounds per 1,000 sq. ft. or 180 pounds per acre. For preplant, over-seeding, newly seeded or sod establishment, use 6.25 pounds per 1,000 sq. ft. or 272 pounds per acre.
