DIRECTIONS FOR USE

TURFGRASS: For maintenance of turfgrass, use 3.6 pounds of WIL-GRO EXTREME IRON per 1,000 sq. ft. or 155 pounds per acre. For repair of damaged turf (such as divot repair, pet damage, traffic wear, insect or disease damage and/or drought stress) use 4.8 pounds per 1,000 sq. ft. or 207 pounds per acre. For preplant, over-seeding, newly seeded or sod establishment, use 4.8 pounds per 1,000 sq. ft. or 207 pounds per acre.

GROUNDCOVER, FLOWERBEDS, VEGETABLE GARDENS: Apply 7.6 ounces of WIL-GRO EXTREME IRON per 100 sq. ft. or 4.8 pounds per 1,000 sq. ft.
