### DIRECTIONS FOR USE

**TURFGRASS:** For maintenance of turfgrass, use 4 pounds of **WIL-GRO FIVE IRON III** per 1,000 sq. ft. or 175 pounds per acre. For repair of damaged turf (such as divot repair, pet damage, traffic wear, insect or disease damage and/or drought stress) use 4 pounds per 1,000 sq. ft. or 175 pounds per acre. For preplant, over-seeding, newly seeded or sod establishment, use 6 pounds per 1,000 sq. ft. or 260 pounds per acre.

**HYDRO-SEEDING:** Add 3 pounds of **WIL-GRO FIVE IRON III** to the hydro-seeding tank per 1,000 sq. ft. of mulch/seed mix coverage.

**GROUNDCOVER, FLOWERBEDS, VEGETABLE GARDENS:** Incorporate 10 ounces of **WIL-GRO FIVE IRON III** per 100 sq. ft. or 6 pounds per 1,000 sq. ft. into soil before planting.
