DIRECTIONS FOR USE

BROADCAST: Uniformly apply 0.5-0.7 pound of product per 100 sq. ft. (5-7 pounds of product per 1,000 sq. ft.) of soil surface. Apply every 90-120 days.

PREPLANT INCORPORATION: Uniformly incorporate 1-1.5 pounds of product per 100 sq. ft. of soil area into the top 6 inches of soil.

INDIVIDUAL ESTABLISHED WOODY ORNAMENTALS: Apply 1.5-2.5 ounces of product per foot of height or width to each individual plant as a side-dress or around the outside of the dripline.

NOTE: 1 measuring cup equals approximately 8 ounces or 15 tablespoons.

For salt sensitive plants, always use the lower recommended rates. Always ring around the outside of the plant. Never pile any fertilizer against the stem, trunk or shoot of plants. Discontinue use 6-8 weeks before expected frost on broadleaf evergreens, deciduous trees, and shrubs. Soil moisture should be adequate before applying fertilizer. Always water well after application.
