DIRECTIONS FOR USE

TURFGRASS: For maintenance of turfgrass, use 4.75 pounds of **WIL-GRO® KWIK KICK** per 1,000 sq. ft. or 210 pounds per acre. For repair of damaged turf (such as divot repair, pet damage, traffic wear, insect or disease damage and/or drought stress) use 4.75 pounds per 1,000 sq. ft. or 210 pounds per acre. For preplant, over-seeding, newly seeded or sod establishment, use 7 pounds per 1,000 sq. ft. or 310 pounds per acre and cultivate into topsoil. After planting, irrigate to keep moist until the turf is established.

GROUNDCOVER, FLOWERBEDS, VEGETABLE GARDENS: Apply 8 ounces of **WIL-GRO KWIK KICK** per 100 sq. ft. or 4.75 pounds per 1,000 sq. ft. into soil before planting. Use 8 ounces per 100 sq. ft. for mid-season application.

For best performance, apply to dry turfgrass and water after application. Do not apply directly to an impervious surface or to ground that is frozen.
