DIRECTIONS FOR USE

TURFGRASS: For maintenance of turfgrass, use 4 pounds of **WIL-GRO[®] LONG DISTANCE** per 1,000 sq. ft. or 175 pounds per acre. For repair of damaged turf (such as divot repair, pet damage, traffic wear, insect or disease damage and/or drought stress) use 4 pounds per 1,000 sq. ft. or 175 pounds per acre. For preplant, over-seeding, newly seeded or sod establishment, use 6 pounds per 1,000 sq. ft. or 260 pounds per acre.

HYDRO-SEEDING: Add 3 pounds of **WIL-GRO LONG DISTANCE** to the hydro-seeding tank per 1,000 sq. ft. of mulch/seed mix coverage.

ORNAMENTALS: Apply 6.5 ounces of **WIL-GRO LONG DISTANCE** per 100 sq. ft. or 4 pounds per 1,000 sq. ft.

For best performance, apply to dry turfgrass and water after application. Do not apply directly to an impervious surface or to ground that is frozen. Sweep or blow off any residual material on adjacent concrete, patios or walkways after application. Keep away from pools, ponds, etc. Do not contaminate potable water.
