DIRECTIONS FOR USE

TURFGRASS: For maintenance of turfgrass, use 3 pounds of WIL-GRO LONG HAUL per 1,000 sq. ft. or 130 pounds per acre. For repair of damaged turf (such as divot repair, pet damage, traffic wear, insect or disease damage and/or drought stress) use 3 pounds per 1,000 sq. ft. or 130 pounds per acre. For preplant, over-seeding, newly seeded or sod establishment, use 4.3 pounds per 1,000 sq. ft. or 187 pounds per acre.

GROUNDCOVER, FLOWERBEDS, VEGETABLE GARDENS: Apply 4.8 ounces of WIL-GRO LONG HAUL per 100 sq. ft. or 3 pounds per 1,000 sq. ft. TREES: Apply ½ pound per 1 inch of trunk diameter and distribute evenly under branches out to dripline.
