GENERAL INFORMATION

WIL-GRO® NURSERY FIELD TOPDRESS is a proven, balanced field topdress material designed to promote root development and produce vigorous, high quality, healthy plants. The ingredients in this multi-nutrient formulation provide the essential elements needed to get plants off to a quick start. This product contains 11.52% slow release nitrogen from a combination of methylene ureas and WIL-COTE® II polymer coated urea to maintain nitrogen levels for up to 90 days. This product has 5.47% slow release nitrogen from methylene ureas and 6.05% from WIL-COTE II.

DIRECTIONS FOR USE

Nursery Topdress (Field Stock Only): Broadcast or side-dress in early spring the amount of fertilizer as indicated by age of plant.

ONE YEAR:

Broadcast Rate: 425 pounds per acre to get 85 pounds of nitrogen per acre.

Side-Dress or Banding Rate: 32 pounds per 1,000 linear feet of row* to get 85 pounds of nitrogen per acre.

TWO YEARS:

Broadcast Rate: 575 pounds per acre to get 115 pounds of nitrogen per acre.

Side-Dress or Banding Rate: 44 pounds per 1,000 linear feet of row* to get 115 pounds of nitrogen per acre.

THREE YEARS:

Broadcast Rate: 725 pounds per acre to get 145 pounds of nitrogen per acre.

Side-Dress or Banding Rate: 55 pounds per 1,000 linear feet of row* to get 145 pounds of nitrogen per acre.

*Side-Dress application rates per acre are based on 40-inch row spacing.

The directions given should be used as a guide. A soil analysis is recommended before each application. Grower judgment and experience should be used with this and all other fertilizer products.
