FIRST AID

DIRECTIONS FOR USE

TURF: In established turf, apply WIL-GRO® ORGANIC at a rate up to 15 pounds per 1,000 sq. ft. Water thoroughly after application and keep moist for up to 4 days. Apply 3 to 4 times per year as needed. Weak or thin lawns may require 4 to 5 applications per year. For new lawn seedbed preparation, apply at a rate of 10 pounds per 1,000 sq. ft. and incorporate into the top 2-3 inches of soil by raking or tilling.

TREE CROPS, SMALL FRUITS, VINES, AND VEGETABLE CROPS: Apply WIL-GRO ORGANIC by broadcast or banded application at a rate of up to 8 pounds per 1,000 sq. ft. Plant density and soil type may require adjustment of application rate. Make applications 2-3 times per year as needed.

For best performance, apply to dry turfgrass and water after application. Do not apply directly to an impervious surface or to ground that is frozen. Sweep or blow off any residual material on adjacent concrete, patios or walkways after application. Keep away from pools, ponds, etc. Do not contaminate potable water.
