WIL-GRO® ORNAMENTAL FIELD STANDARD is a proven, balanced topdress material designed to promote root development and produce vigorous, high quality, healthy plants. The ingredients in this multi-nutrient formulation provide the essential elements needed to get plants off to a quick start and maintain early season growth.

DIRECTIONS FOR USE

Nursery Topdress (Field Stock Only): Broadcast or side-dress in early spring the amount of fertilizer as indicated by age of plant.

ONE YEAR

Broadcast Rate: 340 pounds per acre to get 75 pounds of nitrogen per acre.

Side-Dress or Banding Rate: 26 pounds per 1,000 linear feet of row* to get 75 pounds of nitrogen per acre.

TWO YEARS

Broadcast Rate: 410 pounds per acre to get 90 pounds of nitrogen per acre.

Side-Dress or Banding Rate: 32 pounds per 1,000 linear feet of row* to get 90 pounds of nitrogen per acre.

THREE YEARS

Broadcast Rate: 500 pounds per acre to get 110 pounds of nitrogen per acre.

Side-Dress or Banding Rate: 38 pounds per 1,000 linear feet of row* to get 110 pounds of nitrogen per acre.

*Side-Dress application rates per acre are based on 40-inch row spacing.

The directions given should be used as a guide. A soil analysis is recommended before each application. Grower judgment and experience should be used with this and all other fertilizer products.
