TURFGRASS: For maintenance of turfgrass, use 4.5 pounds of WIL-GRO® PRO TOUR per 1,000 sq. ft. or 200 pounds per acre. For repair of damaged turf (such as divot repair, pet damage, traffic wear, insect or disease damage and/or drought stress) use 4.5 pounds per 1,000 sq. ft. or 200 pounds per acre. For preplant, over-seeding, newly seeded or sod establishment, use 6.8 pounds per 1,000 sq. ft. or 300 pounds per acre.

GROUNDCOVER, FLOWERBEDS, VEGETABLE GARDENS: Apply 7.5 ounces of WIL-GRO PRO TOUR per 100 sq. ft. or 4.5 pounds per 1,000 sq. ft.

For best performance, apply to dry turfgrass and water after application. Do not apply directly to an impervious surface or to ground that is frozen. Sweep or blow off any residual material on adjacent concrete, patios or walkways after application. Keep away from pools, ponds, etc. Do not contaminate potable water.
