STORE IN COOL AND DRY CONDITIONS

TANK MIX COMPATIBILITY

This product is compatible with many agricultural pesticides. However, if specific information is not available, a jar test for compatibility should be conducted prior to large scale mixing.

CROP SAFETY

This product has been tested on a number of crop varieties with no phytotoxicity observed at labeled rates; however, this product has not been tested on all varieties and cultivars. Due to the large number of plant species and their associated varieties or cultivars, and due to variable growing conditions, it is impossible to test every plant for tolerance to this product. It is the responsibility of the user to determine if this product can be used safely prior to commercial use. In a small test area, test the specified rates on plants for phytotoxicity prior

to general use. Before using any tank mix, test the combination on a small portion of the crop to be treated to ensure that a phytotoxic response will not occur as a result of application. Treat a small group of target crops including plant cultivars and evaluate for 3 to 7 days prior to making an application to your entire crop.

FIRST AID
