Active ingredient: 88% Starch-g-poly (2-propenamide-co-2-propenoic acid) potassium salt

Inert ingredient: 12% water

### GENERAL INFORMATION

Zeba® SP is a starch-based superabsorbent polymer that breaks down naturally over time in soil. It is designed to rapidly absorb and maintain moisture in the root zone, releasing moisture back to plants as needed.

### STORAGE INSTRUCTIONS

Keep Zeba® SP in its original container, tightly closed and under dry storage conditions.

### USE DIRECTIONS

#### Agricultural Crops

Apply Zeba® SP 4 - 6 inches (10 - 15 cm) below the soil surface in proximity to root zone at a rate of 3 - 10 lbs per acre (3.5 - 11 Kg per hectare). Use higher rates of 7 - 10 lbs per acre (7.5 - 11 Kg per hectare) in soil with low moisture holding capacity for optimal moisture retention.

#### Small Seeded Plants

Apply Zeba® SP in drill row at planting at rate of 1 - 4 lbs per acre (1.2 - 5 Kg per hectare) for alfalfa, grass seed and other small seeded crops and plants.

#### Anti-Crustant

As an anti-crustant, to aid in germination and stand establishment, band directly over the seed row before the press wheel. Apply Zeba® SP at a rate of 2 - 4 lbs per acre (2.5 - 5 Kg per hectare).

#### Newly Planted Trees & Vines

For new plantings, use 1 - 2 tbsp per tree. Place half the Zeba® SP in the planting hole and mix the remaining half in the backfill soil.

#### Soil Mix

Use 10 - 28 g (1.33 - 4 tbsp) per cubic foot (28.3 L) of potting soil, or 0.5 - 1.5 lbs (2 - 6 cups) per cubic yard, or 300 - 900 g (2.75 - 8 cups) per cubic meter. Incorporate Zeba® SP uniformly and thoroughly into dry soil mix.

#### Shrub/Tree Planting/Pot Transplants

For bare root plantings, use 1 - 2 tbsp (7 - 14 g) per tree. Transplanting potted containers and B&B:

Place half the Zeba® SP in the planting hole and mix the remaining half with the backfill soil.

### Localized Dry Spot Repair, Patching, and Compacted Areas

Aerify affected areas with at least 1/2 inch (1.25 cm) diameter aerifier tines, spread Zeba® SP at the rate of 4 - 8 cups (1 - 2 lbs) per 1,000 square feet (0.5 - 1 Kg per 100 square meters) over area (soil or turf area should be dry), brush or drag granules into holes and water thoroughly. To be effective Zeba® SP must be placed below the grass and 1 - 3 inches (2.5 - 7.5 cm) below soil surface.

### Plant Beds & Landscapes

Broadcast or band 1 - 1.5 lbs (4 - 6 cups) per 1,000 square feet or 4.5 - 9 cups (0.5 - 1 Kg) per 100 square meters and rake or work into the top 3 - 6 inches (8 - 15 cm) of soil prior to planting.
