DIRECTIONS FOR USE

Add ZENITH to the spray tank at the rate specified by the pesticide label. If specific rates are not provided, see USE RATES section for detailed information on rates. Before mixing ZENITH, a compatibility test is recommended. See the pesticide label for detailed instructions on compatibility testing. If all components of the solution are compatible, add the contents of the compatibility test to the spray tank and begin the mixing process.

USE RATES

ZENITH should be used at either 1.5 or 2.25 pounds/acre.

ZENITH may be used at 1.5 pounds/acre (45 lb. bag/30 acres) to meet the adjuvant requirement if spray volume is 12 GPA or less.

ZENITH may be used at 2.25 pounds/acre (45 lb. bag/20 acres) to meet the adjuvant requirement if spray volume exceeds 13 GPA.

MIXING INSTRUCTIONS

IMPORTANT - Add ZENITH to the spray tank first before adding any other tank mix product, unless the tank mix pesticide(s) or additives direct otherwise.

Mixing Order

1. Fill tank 1/2 full of water and begin agitation.
2. Slowly add the required amount of ZENITH and allow the product to completely dissolve.
3. Continue filling spray tank with water and add the tank mix components as directed on the pesticide label(s).

STORAGE & DISPOSAL
