DIRECTIONS FOR USE

Avoid spraying in the heat of the day or when the plant is under moisture stress to achieve optimal product performance. DO NOT spray to the point of runoff.

Recommended mixing sequence: water, adjuvants, pesticides, Valent BioSciences nutrient products, other fertilizers, balance of water while agitating. When mixing with high phosphate fertilizers, add a citric acid buffer until the pH is 4.5 to 5.0 to improve compatibility and uptake. Ensure agitation is available when mixing with calcium fertilizers. A standard jar test is recommended before tank mixing.

RATES & TIMING FOR ALL CROPS

Orchards and Vineyards: **1-3 quarts/acre**

Field and Row Crops: **0.5-2 quarts/acre**

Vegetables and Other Specialty Crops: **0.5-2 quarts/acre**

Apply any time during growing season; repeat as needed.

Secuencia de mezcla recomendada: agua, adyuvantes, pesticidas, productos nutritivos de Valent BioSciences, otros fertilizantes, equilibrio de agua mientras se agita. Cuando mezcle con fertilizantes con alto contenido de fosfato, agregue un amortiguador de ácido cítrico hasta que el pH sea de 4,5 a 5,0 para mejorar la compatibilidad y la absorción. Asegúrese de que haya agitación disponible al mezclar con fertilizantes de calcio. Se recomienda una prueba de frasco estándar antes de mezclar en tanque.
