Zinc 9% will correct zinc deficiencies when used at an optimum rate of application. The actual use rates may vary based on soil conditions, pH and organic matter. Follow soil tests or plant analysis to determine the correct amount of Zinc 9% to apply.

Prior to use read all directions on this label and on the label of the product used. The product label for specific usages and restrictions have precedence over directions for uses referred to on this label.

MIXING INSTRUCTIONS

1. Put 1/3 of water or fertilizer* in tank
2. Add any pesticides**
3. Fill tank with balance of water or fertilizer*
4. Add Zinc 9%
5. Agitate adequately to mix
