GENERAL INFORMATION

ZINCHE ST is an aqueous suspension suitable for seed treatment to control early zinc deficiencies prior to planting.

DIRECTIONS FOR USE

Use 8 fluid ounces of this product diluted with an equal amount of water per 100 pounds of seed and apply as a slurry treatment by machine. This product is compatible with many of the commonly used seed treatment fungicides. Dilute with water prior to mixing with other chemicals.

Note: Treated seed must not be used for human consumption or as animal feed.

STORAGE AND DISPOSAL

Freezing temperature is 25°F (3.9°C).

Do not contaminate water, food or feed by storage or disposal.

PRODUCT DISPOSAL: Follow all governmental requirements for the disposal of agricultural spray solutions.
