Start applications at the first sign of disease. If conditions favour early infections, make the first application soon after transplanting or when direct- seeded tomatoes are 15 cm high. Repeat at regular 7 to 10 day intervals. May be applied up to 7 days before harvest. Do not apply more than 8.26 kg Ziram 85W Fungicide (7.02 kg a.i.) ha per season.

RESISTANCE MANAGEMENT RECOMMENDATIONS

For resistance management, please note that ZIRAM 85W Fungicide contains a Group M fungicide. Any fungal population may contain individuals naturally resistant to ZIRAM 85W Fungicide and other Group M fungicides. A gradual or total loss of pest control may occur over time if these fungicides are used repeatedly in the same fields. Other resistance mechanisms that are not linked to site of action but specific for individual chemicals, such as enhanced metabolism, may also exist. Appropriate resistance-management strategies should be followed.

To delay fungicide resistance:

- Where possible, rotate the use of ZIRAM 85W Fungicide or other Group M fungicides with different groups that control the same pathogens.
- Use tank mixtures with fungicide from a different group when such use is permitted.
- Fungicide use should be based on an IPM program that includes scouting, historical information related to pesticide use and crop rotation and considers cultural, biological and other chemical control practices.
- Monitor treated fungal populations for resistance development.

COMPATIBILITY

Ziram is compatible with most commonly used insecticides and fungicides but should not be mixed in the spray tank with Bordeaux, Fixed Copper, lime sulphur or hydrated lime; when mixing with Guthion, use the wettable powder only.
