PRODUCT INFORMATION

ZoneCoverageTM is a blend of modified vegetable oil concentrate and organosilicone surfactant. It provides effective wetting and spreading of various pesticides. The modified vegetable oil component of ZoneCoverage causes penetration of the pesticide into the plant tissue.

Care should be used when applying ZoneCoverage with post-emergence herbicides on sensitive crops during times of high heat, high humidity and drought stress. Phytotoxicity may occur if applied under these environmental conditions. Under such conditions, apply the tank mixture in a small area of the field to determine if any adverse effects are observed.

DIRECTIONS FOR USE

Prior to use, read all label directions of both adjuvant and pesticides in the tank mixture.

To ensure adequate mixing, shake containers and/or provide recirculation of totes and bulk tanks prior to adding to the tank.

MIXING INSTRUCTIONS

- •Fill tank one-half full of water.
- •Add the required amount of pesticide to the tank while agitating.
- •Add the remainder of water.
- •Add the recommended amount of ZoneCoverage to the tank last.
- •Agitation is required during mixing and continue through completion of the spraying application.

Always provide good agitation when adding ZoneCoverage to the spray mixture.

Special Note: ZoneCoverage may increase crop response to various selective herbicides. Applicators should evaluate any observed response prior to wide usage.

USE RATES

GENERAL: Use 4 fluid ounces of ZoneCoverage per acre. For spray volumes greater than 30 gallons per acre, use ZoneCoverage at a minimum of 0.1% volume/volume.

AQUATICS: ZoneCoverage may be used with aquatically labeled pesticides. Care should be taken to follow the recommended adjuvant rate that is specified on the pesticide label.

BACKPACK OR HANDHELD SPRAYERS: Use 1-3 teaspoons per gallon of spray mix.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage and disposal.

STORAGE: Store in original container only and keep tightly closed. Store in closed storage areas. Use caution when moving, opening, closing or pouring.

PRODUCT DISPOSAL: Dispose of contents in accordance with all government regulations. Improper disposal of excess pesticide, spray mixture or rinsate is a violation of federal law. Wastes resulting from use of this product may be disposed of on site or at an approved waste disposal facility.
